6. Governance

Context

- In CC12, a Council member raised the point that the launch of the updated CAF (V1.4) would be the Council's mandate vs. subject to an all signatory vote. It was requested for the Council to discuss this issue in next Council meeting (CC13).
- The Governance Committee had a meeting on the 24th of June where this topic was part of the agenda. All members of the Committee were present including the new chair and the new candidate Dan Danielsen.
- Governance on future launch tool- decision making, following discussion CC11/CC12: who decides on launch new CAF/Tool
- Council continuity: During Nov 2020- Jan 2021 election, all stakeholder representatives seats (9) will be up for election. How will this impact continuity of the Council?

7. General Assembly

Context

• The General Assembly due to take place in Copenhagen in May 2020 was postponed due to the global pandemic, with a provisional new date of October 2020. At CC10 the Council approved a recommendation to not hold an in-person General Assembly this year and to hold a series of virtual events instead. This memo sets out plans for a virtual General Assembly in Q4 2020.
