4. Operational Updates

Context

- High level progress updates
 - o Adoption 2021
 - o CAF, VO, Tech, Comms & SHE
 - Internal Management
 - Higg Pricing Policy (see email Janet to Council 11 October)
 - Reported against the four strategic aims (from 5-year strategic plan) rather than specific updates. Highlights include:
 - Adoption
 - On track to reach adoption target in 2021 (currently at 84% (3,215 / 4000 VRF)
 - Flattening VRFs but given the previous year trends, we expect to reach 4000 before end



of year

- Unlocked resources of \$10 million USD
- Operations
 - Continued improvement and expansion
 - Average number of tickets reduced since 2020
 - Continued work with ITC on translations and e-training
- CAF / VO
 - Priority and focus on Better Work essentials
 - CAF 1.5 in Q1 2022 is a limited major update (with the aim to stabilize the tool)
 - CAF 1.6 will be launched in 2023 with major updates in collaboration with Better Work
 - Re-branding Verification Oversight to Data Quality and Integrity
 - Pilot has been launched to engage worker voices in the process (Worker Engagement Technology or WE Tech Pilot) – outcome in Q1 2022 and will use output to engrain in future process
- Tech
 - System is scaling well
 - Working on sharing issues we can now share VRFs between hosts
 - Commencing evaluation of Accredited Hosts
- o Comms / SHE
 - Over 50 brands on acceptance list (including recent addition Fair Trade USA)
 - Better Buying Institute / SLCP joint progress release had great coverage, good exposure at recent events (ITC T4SD, WTO Public Forum, OECD Global Deal)
 - Signatory survey in progress, signatory webinar (14th December), Secretariat building out key personas which will be shared to Council
 - SHAHI have measured SLCP impact through a case study now on our website
