Context on updates to SLCP Governance Document

- Memo: Updates to the SLCP Governance Document / SLCP Signatory Charter
- To protect CAF IP, further clarification of earlier assumptions that signatories and stakeholders contributing to the CAF cannot claim ownership of the CAF.
 - Based on advice from SAC's lawyer.
 - Aligned with Signatory Charter (to be updated accordingly).
- Clarification of Counselor role: previously targeted towards harassment and discrimination, propose to widen the scope and use the Counselor as an additional support channel for staff and Council.
- As a 2022 plan priority, the Secretariat suggest establishment of a new Technical Advisory Committee (TAC) on Data Insights.
 - This requires Council approval. Following this approval prior to inclusion in SLCP's Governance document.

2022 Strategic Priorities and Themes

1. Industry Adoption

- CAF adoption reaching **8,000+ VRF**, update to v1.5
 - Ease of implementation
 - Wide applicability, supply chain diversification
 - Compatibility with social standards
- 'Satisfied customers & implementing partners (e.g. AHs)'*

2. Unlocking Resources

- Reduce costs /verification (CAF v1.5)
 - Avoid audit duplication, increase SLCP acceptance
 - Measure savings and start showing redirection of resources
 - Partnerships with organizations to improving labor conditions
- 'Net cost reduction resulting in more impact'*

3. Data Access & Comparability

- Credible & relevant data (CAF v1.5)
 - Interpretation of verified data: 'Law Overlay' and value add by AHs (ensure options of choice)
 - Start verified assessment data insights workstream
- 'SLCP becoming THE source of social & labor data'*

4. Organization and Financial Resilience

- Earned income **100%** of core budget, net profit and building up reserves
 - Well resourced and flexibly organized team, clarity on roadmaps and communication
 - System solutions for daily operation
 - Legal confirmation independent governance, formalized organization structure/hosting agreement

8. Collaboration ITC

With Guest Joe Wozniak, ITC

Context/ Discussion

- ITC strategic partner since SLCP program creation. A lot of SLCP success is due to the ITC collaboration.
- ITC is a joint WTO/UN agency working with SMEs to improve their ability to trade in a way which is sustainable and reduces costs and move towards harmonized standards to be more resilient.
- The work of SLCP and its mission and stakeholders is aligned with the ITC strategic priorities and with EU policy. This is apparent since 2017 and has only increased in relevance since then.
 - COVID has increased pressure on SMEs and their resilience. The contribution of SLCP to audit harmonization is a key area of alignment.
 - Sustainability regulation and policy has changed dramatically in recent years. As the EU moves towards a more hands on regulatory position, ITC sees SLCP as a frontrunner in supporting the implementation of incoming policies.
- We have achieved a lot in 2021:
 - ITC IT work with SLCP in the CAF 1.4 and onboarding of ILO/BW
 - Milestone of 4,000 VRFs in 2021, hugely positive
 - Bolstered ITC team in 2021, who will support scaling and moving forward
 - Data insights: published with SLCP and a good precursor for 2022
 - Data map and amfori benchmarking with the BSCI
 - Working with new brands and passive brand hosts on the SLCP sharing module
